Description of Work Executed Today

Eastside Mixing and Drying Activity:

- Day Shift:
- Tractor and Pans relocated dry soils from the dry ponds to the HP-2 stockpile
- Worked on haul road along beta ditch stockpile.
- Disked wet soils spread over dry ponds with D8 and discs.
- Watered dry ponds in 7A parcel with sprinklers.
- Preparing dry ponds for load out.
- Conducted dust monitoring.
- Prepared area for night haul.

- Night shift: Continued Hauling soils from Beta Stockpile to CAMU Phase 1 for placement.

CAMU Activity:

Excavation .

- Day Shift:
- Worked on finish grade for floor and side slopes in Phase II.
- Screened 1" minus soils.
- Maintained haul roads.
- Prepare area for night haul. Prewater haul roads.

- Night Shift:
- Hauled soils from eastside beta ditch stockpile to CAMU, phase 1 for placement. 248 Loads @ 20cy/load = 4,960 cy. (11 trucks).
